Parking Structure C7

1. After going out of the Union U-Drive, turn **LEFT** onto **GREEN** Street.
2. Go past two stop lights to **FIFTH** Street. Turn **LEFT** onto **FIFTH**.
3. Go one block to **JOHN** Street. Turn **LEFT**. Go one block to **PARKING GARAGE**. Parking is on the **TOP** at bagged meters with MAPLA on bags.
4. See attached Map.

Parking Structure D5

1. South off I-74 at Lincoln Avenue. Go past Green one block to Illinois Street, turn Right. Turn into Krannert off Illinois before Goodwin. Or...
2. Turn Right on Green, go to next stop light which will be Goodwin Street, turn left and go to Illinois Street. You can either turn left and go into parking structure under Krannert, or go into Krannert off Goodwin. See attached map.

Directions to the Public Parking Lot

1. After going out of the Union U-Drive, turn **LEFT** onto **GREEN** Street.
2. Go through the **SIXTH** Street stop light, Turn **Right** into the **PUBLIC PARKING LOT** just after the light.

Re: Directions to the Illini Union

Thank you for your response to attend our Law Day here at the University of Illinois. We are looking forward to having you here. Below are directions and reminders that I hope will help you.

Our event will be October 21st, 2009 located in Illini Rooms A, B, & C in the Illini Union; Check-in will be starting at 10 a.m. and the event will start promptly at 11 a.m. and will last until 3 p.m.

Coffee, tea and refreshments will be available starting at 10 a.m. A box luncheon will be available around noon. Table placement for the event will be in alphabetical order. Name plates will be on the table when you arrive, or just ask at the registration table if you have any questions.

Although parking arrangements are not complete at this time, it is expected that bagged parking meters (MAPLA Law Day) for participants will be available on the top level of a parking structure at the corner of Sixth and John (C7) and below Krannert located off Goodwin (D5). There is more than one level in this parking lot. Last year the parking was in the south entrance. They will be bagged marked (MAPLA Law Day). This will be reviewed in the middle of August. Parking is available in our Shuttle lot, out by the Assembly Hall at First St. and Kirby Ave. E14 is also available by obtaining a Visitors Pass. You may obtain a pass by calling Campus Parking at (217) 333-3530.

I-74 to Illini Union:

I-74 to Lincoln Ave. Exit- Go south on Lincoln approx. 2 miles to Green St.- Turn right on Green and follow approximately 3 blocks; the Illini Union will be on the left side of the street. It is a large colonial style brick building with a circular driveway.

I-57 to Illini Union:

I-57 to I-74 (East/Champaign Exit) - follow directions above for I-74 to Lincoln Ave.
I-74 to Parking Structure on 6th & John: (pending until September 1, 2005)

I-74 to Lincoln Ave. Exit- Go south on Lincoln approx. 2 miles to Green St.- Turn right on Green and follow approx. 6 blocks to Fifth St.
Turn left on Fifth and go 1 block to John, turn left onto John and the Parking garage will be on the right side (on the corner of Sixth and John). The top level will have meters bagged and marked MAPLA LAW DAY. First come. You may also park at any meter for the day in the garage for .25 (quarters only) per 20 minutes.

I-74 to Parking Structure at Krannert on the corner of Illinois and Goodwin.
I-74 to Lincoln Avenue Exit - Go south on Lincoln approx. 2 miles to Green Street.
Go thru Green Street to Illinois Street (1 Block) Turn Right. You will enter Krannert Parking from Illinois Street. Upper and Lower Levels where there are bagged meters marked MAPLA Law Day.

Parking meters are first come/first serve.
